Examples of Charity fundraising by Skydiving:

Skydive Jersey Still require the full payment for each charities Tandem Skydive.

Individual Fundraisers

The participant should come to an arrangement with the charities fundraiser, about what proportion of the collected sponsor money can be used towards the cost of the jump. **A usual percentage is 50%**. Though this is not a requirement.

In this case, in order to qualify for a **FREE** jump, the participant is then required to collect at least £660 of sponsor money, where upon £330 would pay for the jump and £330 would be donated to the charity concerned. Any additional money over and above £660, would also be donated to charity.

If there is any shortfall in raising the money for the cost of the jump, then this must be paid by the participant.

Example 1 50%

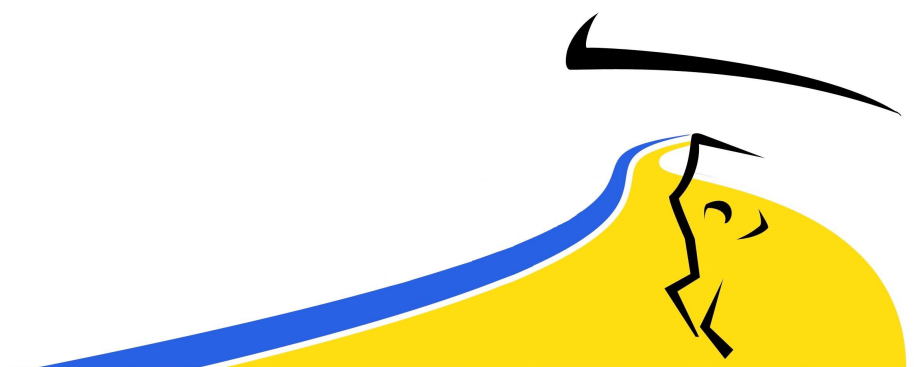
£200 of sponsorship is raised, £100 of this could be used towards the cost of the jump, leaving the participant to fund the remaining £230 in order to pay for the skydive cost of £330. The remaining £100 is donated to the charity.

Example 2 50%

£400 of sponsorship is raised, £200 of this could be used towards the cost of the jump, leaving the participant to fund the remaining £130 in order to pay for the skydive cost of £330. The remaining £200 is donated to the charity.

Example 3 50%

£500 of sponsorship is raised, £250 of this could be used towards the cost of the jump, leaving the participant to fund the remaining £80 in order to pay for the skydive cost of £330. The remaining £250 is donated to the charity.



Group or Corporate Fundraising

A popular fundraising method, useful for group events, is to set the amount that the participant should pay for the skydive first, with a proviso that a minimum amount of sponsorship money is achieved.

Example 4

The participant pays the charity £200 to register for the skydive event, on condition that a minimum of £600, will be raised for the charity, in sponsorship money. Total income to the charity, should then be £800.

The charity pays for the Skydive, £330 for each participant, leaving £470 charity donation from each participant.

Example 5

The participant pays a £130 deposit for the skydive, on condition that a minimum of £600, is raised for the charity. The participant then pays a £100 balance on the day of the skydive, if associated with the charity event.

The Charity should be sure to receive the £600 sponsor money, and will be asked to pay the outstanding balance of £100 for each jumper, leaving a surplus of £500 for the charity.
